

Privacy Policy

The RRP America First Academy (Texas Non-Profit Corporation) and RINO Removal Project (Kentucky C Corporation) ("we," "us," or "our") respects your privacy. This Privacy Policy explains how we collect, use, and protect your personal information when you visit our website www.rinoremovalproject.org, donate, or volunteer with us.

1. Information We Collect

We may collect the following types of information:

- **Personal Information:** Your name, email address, phone number, mailing address, and payment information (when you donate).
 - **Volunteer Information:** Any details you provide when signing up to volunteer (e.g., availability, skills, background).
 - **Background Check Information** (for certain roles): If you apply for a volunteer position that involves sensitive duties (such as handling finances), we may collect additional information to conduct a background check. You will be notified and asked for consent before any background check is performed.
 - **Automatically Collected Data:** Basic information about your device and browser (like IP address, browser type, and pages visited) using cookies or similar tools.

2. How We Use Your Information

We use your information to:

- Process donations and send receipts
 - Communicate with you about our work, events, or volunteer opportunities
 - Respond to your inquiries
 - Improve our website and services
 - Comply with legal obligations
 - Conduct background checks for certain volunteer positions (with your consent)

3. How We Share Your Information

We **do not sell** your personal information. We may share your information only:

- With trusted service providers who help us run our website, manage volunteers, or process donations
- As required by law or to protect our legal rights
